Re: Qualifications 2022 Update

I am writing to provide you with an update regarding Qualifications 2022.

The COVID-19 pandemic has disrupted the learning of all students. As a result, the arrangements for examinations and assessments in 2022 have been under consultation. Ofqual, the examinations regulator, have now released some updates regarding GCSE, AS and A Level qualifications in 2022.

In considering their approach to examinations and assessments in 2021 to 2022, Ofqual are being guided by the principles of fairness, flexibility, and certainty. In particular, the government's specific policy objectives with regard to examinations and assessments are that:

- students can progress successfully to the next stage of their education or to employment,
- every effort should be made to maintain the standard and rigour of the qualifications, to the extent this is possible given the circumstances,
- the subject content, specified by the Department for Education, which forms the foundation of the qualifications should not be changed.

As a result of the consultation:

- Adaptations have been made to the *content* of some qualifications, namely GCSE English Literature, History and Geography and, as such, centres have some choice regarding topics and content. At Ivybridge Community College, we have made our decisions based on what we believe will be best for our students given our curriculum planning in each subject. What this means for our students is outlined in the table attached and will be communicated to all students by their teachers.
- Practical work in GCSE Sciences can be delivered via demonstrations if necessary.
- A minimum number of Common Practical Assessments (PAGs) in A Level Sciences will be allowed for students to demonstrate their competence.
- GCSE and A Level Art and Design will be assessed on portfolio only.
- Students will be provided with a formula sheet for GCSE Mathematics.
- Students will be given a revised equation sheet for GCSE Physics and Combined Science, covering all the equations required in the subject content.

For all GCSE, AS and A Level subjects which have examinations in summer 2022, except for those with optional content as listed above, each awarding organisation will provide **advance information** on the focus of the content of summer 2022 examinations. The policy intention of providing advance information is that it will support students' revision and will enable teachers to plan to adapt their teaching in the second half of the spring term if necessary, in the time before the examination, in the context of the COVID-19 pandemic which has disrupted the education of students sitting examinations in summer 2022. This approach, and precisely how it will be used by all centres, will vary across subjects to best reflect the qualification structure.

In line with the DfE's policy decision in England, all examination boards will make advance information available on their public websites at the same time by 7 February 2022 at the latest. Schools and Colleges will not receive this information internally any earlier than when it is

published online. The DfE has also decided to retain the flexibility for advance information to be deployed at other points ahead of 7 February 2022 if circumstances require. At least a week's notice will be given if it is decided that advance information will be released earlier than 7 February 2022.

The advanced information materials may be used at any point from the date of release; however, they cannot be brought into the actual examinations.

In some subjects, changes have already been made by the government to non-examination assessment (NEA) and fieldwork requirements. A summary of these changes for our courses at Ivybridge Community College can be found in the attached table.

All updates outlined on this letter have been announced by Ofqual and are designed to mitigate the impacts of the disruption that students have faced during the pandemic without undermining the value of their qualifications and their ability to progress successfully to further study.

A summary of any optional changes in the context of Ivybridge Community College and updates to NEA/fieldwork have been outlined in the attached table.

It is important to point out that at the current time, the government intends for the summer examinations to take place as planned. In the event that examinations are cancelled and grades are determined via teacher assessment, then it is likely that student performance in upcoming November mock examinations could form part of the evidence used; however, should this be necessary, the particular context and conditions of these assessments would be taken into account.

Ivybridge Community College is an effort driven College where we believe that with hard work every day there are no limits to a student's potential or any secrets to success. We know that the COVID-19 pandemic has been challenging for all students in different ways and disruption to learning has continued for some students this year. All staff at the College are committed to supporting our students to achieve their very best grades in their qualifications this summer.
