



Level 3 RSL Subsidiary Diploma for Music Practitioners

Overview of the course:

This is a vocational course, which offers a broad basis of study for the music sector with a focus on performance, developing instrumental technique, music theory and professional practice. There are two mandatory units: Rehearsal Skills and Live Music Performance, with focus on musicianship skills, and Planning a Career in Music, with focus on Music industry. In addition to these mandatory units, students may choose from a selection of optional units, which could include:

- Composing Music
- Contextualising Music
- Auditioning for Music
- Practical Musicianship
- ... and many others

Students who study RSL Music will take part in many exciting concerts and events at the College and in the community, and develop their experience with the ensemble leaders as well as music practitioners from the industry.

What will you study?

With the emphasis on practical music making, this course will appeal to students who wish to develop their playing and/or singing skills, their musical understanding, theoretical musical knowledge, leadership and networking skills and learn about how music fits in to society and cultures around the world. Experience and confidence when setting up and sound checking for professional events and live music performances in a variety of venues will also form part of this course. A knowledge and understanding of how the music industry works will be an important feature of the course and it should appeal to students with a wide range of musical interests.

The course delivery is largely practical in nature and makes full use of the Music department facilities. There are dedicated practice huts, performance rooms with PA, two recording studios and teaching rooms with a computer suite and relevant software.

Assessment

Parts of the course are externally assessed. The remainder of the course is assessed by the teacher, as well as internally moderated, and then verified by the awarding body. The results of assessment for all of the units are aggregated and students are awarded a Pass, Merit, Distinction or Distinction*.

Possible career path?

- This course will prepare you for higher education or employment.
- It will provide an introduction to the study of the music sector, and give you the underpinning knowledge and skills needed to meet industry requirements.
- This course develops the transferable and higher order skills so highly regarded by HE and employers.
- A Music qualification shows that you are a well organised and highly motivated student who can take the initiative and can work well with others. It can, therefore, help you in applying for jobs or courses for which these are desirable characteristics.
- You will be developing leisure skills which will be of benefit to you throughout your life.

Entry requirements

Five GCSEs Grade 9 - 5, including English and Mathematics **and** a Grade 5 or above in Music, or a Merit or above in Level 2 BTEC First Award in Music or Level 2 RSL Music.

If a Level 2 Music qualification has not been studied but you have gained singing and/or instrumental skills by other means, please ask the Music Department staff for advice and seek an audition to demonstrate your musical ability.

Special Requirements:

This course is offered as one block of study and is equivalent to one and a half A Levels. You will be following a performance pathway. Other pathways in composition, technology and business are available and can be discussed with the Head of Music.

Enrichment Opportunity

We recognise that progress in a musical instrument or singing is vital for students studying for a Level 3 course in Music at the college. Students studying Music in the Sixth Form can apply for subsidised individual lessons in an instrument or in singing. Any subsidy is conditional on good attendance and engagement, and can be withdrawn if these conditions are not met. Students can make an application at the start of the course.
